Directions

FROM THE EAST

Take I90 West to Exit 35. At the traffic circle, take the fourth exit onto 298 East. Stay on 298 for about three minutes. The Bull and Bear will be on your right.

FROM THE WEST

Take I90 East to exit 35 and then follow the directions above.

FROM THE NORTH

Take I81 South to Exit 29S, I481. From 481 take Exit 8, Northern Blvd.

Stay on Northern Blvd for about a mile and then turn right onto 298 W then another right onto Rt. 86 Kinne St. In about 500 feet turn right onto Court Rd. Then left onto 298 East. Half a mile down the road the Bull and Bear will be on your right.

FROM THE SOUTH

Take I81 North to Exit 16A, I481N towards Dewitt and then take Exit 5W, Kirkville Rd.

In about a half a mile turn onto Franklin Park Dr. then turn right onto to Rt. 86 Kinne St in about a mile. Turn right onto 298 East and the Bull and Bear is just over half a mile down the road on the right.
